Office Order

This is to notify that the Vice-Chancellor of Bangladesh Open University (BOU) is hereby granting Extraordinary leave without pay to **Ms. Merine Sultana**, Assistant Professor (Education), School of Education, Bangladesh Open University for a further period of 01 (one) year to undertake Master of Education Program under International Graduate Student Entrance Scholarship (IGSES) at the University of Manitoba, Canada as per decision of the 106th meeting of Standing Committee for Advanced Studies, Training and Research of BOU held on 15 October 2025 on the following terms and conditions:

1. That the leave will be effective from 31 August 2025;
2. That on return, after completion of the said study, she will work in Bangladesh Open University for the same period of leave availed of, failing for which she will have to pay compensations to BOU as may be assessed by the university;
3. That the progress and standard of higher study should be satisfactory and she should send progress reports on expire of every 6 (six) months;
4. That her service during her Extraordinary leave without pay will be governed by BOU rules;
5. That as soon as she completes the said course, she will join the Bangladesh Open University;
6. BOU will not bear any expenses for her Master of Education Program in University of Manitoba, Canada.
