Office Order

This is to notify that the Vice-Chancellor of Bangladesh Open University (BOU) is hereby granting Extraordinary leave without pay to **Tahmina Rasna**, Assistant Professor (Political Science), School of Social Sciences, Humanities and Languages, Bangladesh Open University for a period of 06 (six) months (from 23-01-2026 to 22-07-2026) to complete PhD Program under Scholarship (Awarded a 50% tuition fee reduction) at the University of Lincoln, England, UK as per decision of the 107th meeting of Standing Committee for Advanced Studies, Training and Research of BOU held on 15 April 2026 on the following terms and conditions:

1. That the leave will be effective from 23 January 2026;
2. That on return, after completion of the said study, she will work in Bangladesh Open University for the same period of leave availed of, failing for which she will have to pay compensations to BOU as may be assessed by the university authority;
3. That the progress and standard of higher study should be satisfactory and she should send progress reports on expire of every 6 (six) months;
4. That her service during her study leave will be governed by BOU rules;
5. That as soon as she completes the said course, she will join the Bangladesh Open University;
6. BOU will not bear any expenses for her PhD Program in the University of Lincoln, England;
